Mick Chantler, a history professor at the Osher Life Long Learning programs, who spoke about the business end of baseball, specifically the Oakland A's, which has the second to lowest payroll but the best record for last year, beating the high-spending Yankees, Angels and Giants. The A's produced the same product (94 wins) as the Giants but at half the cost. Mick also shared information from the book, Money Ball: The Art of Winning an Unfair Game, which details how Billy Beane outfoxes the big guys by focusing on runs and not muscles or good looks.
